CADASTRAL SURVEYORS LICENSING BOARD OF NEW ZEALAND

Introduction

I have the privilege of presenting this Annual Report representing the period from 1 July 2008 until 30 June 2009.

The first term (2002-06) of the Cadastral Surveyors Licensing Board was one of establishment of procedures for the issuing and renewing of licences and the preparation of competency standards for surveyors to meet in order to obtain a licence. As the second term (2006-09) of the Board approaches its expiry, it can be seen as one in which the Board has developed and implemented procedures and processes for the disciplining of surveyors who have been alleged to have failed to meet the required standards. As new complaints appear the Board is constantly challenged by new situations that have led to questions about the competency of an individual.

The past year has seen the Board's activity generally maintained at what has become a normal level. The number of licences is marginally greater than last year, continuing the recent trend but to a lesser degree than in recent years, and indicating that there are sufficient new licences to replace those surveyors who have retired or otherwise failed to renew. Continued high level of demand for entry into the University of Otago School of Surveying, combined with the fact that all applicants for membership of the New Zealand Institute of Surveyors Inc. choose the cadastral option as one of their disciplines, suggests that this trend is likely to continue at least in a stable state.

The Board's current financial position is also stable, though the years outruns may prove a small deficit. The Board deliberately exercised constraint with the question of raising the fee for the forthcoming year given the present recessionary climate, recognising that this may cause a small deterioration of the overall financial reserves of the Board. The Board has considered this to be only of minor concern.

Jurisdiction

The Cadastral Surveyors Licensing Board of New Zealand was constituted by section 10 of the Cadastral Survey Act 2002 and is the successor of the Surveyors' Board first constituted under the New Zealand Institute of Surveyors and Board of Examiners Act 1900.

Functions

The functions and duties undertaken by the Board are set out in section 11 of the Cadastral Survey Act. (See Appendix A).

In summary, the primary function of the Board is the licensing of suitably qualified surveyors with current competence to conduct cadastral surveys and lodge them in the cadastral record. For this purpose the Board sets standards for the education and the practical experience required to obtain and retain a cadastral licence.

The Board exercises disciplinary powers in cases where a cadastral surveyor is charged with negligence, incompetence, falsification or failure to observe the Surveyor-General's Rules for Cadastral Surveying. The Board has the authority to suspend or cancel the licences, or place a surveyor under the supervision of

another licensed cadastral surveyor, where professional misconduct is proven. Licenses must be renewed annually.

In addition, the Board participates in reciprocity arrangements with the eight Australian State and Territory boards. The reciprocating agreement is currently under review.

Membership

Under section 13 of the Act there are five board members appointed by the Minister of Land Information.

The present Board members are:

Messrs B D Gawn and M D Sinclair, appointed as nominees of bodies representing licensed cadastral surveyors pursuant to s.13(2)(a);
Messrs G D Clark and B J Coutts appointed pursuant to s.13(2)(b);
Ms J N Kirk, being a person who is not and never has been a licensed cadastral surveyor and is not employed in the surveying profession is appointed pursuant to s.13(2)(c);
the Surveyor-General, Dr D B Grant, as an *ex-officio* member of the Board pursuant to s.13(1)(b).

Ms F H Russell and Mr P M Smidt were appointed by the Minister as substitute members of the Board.

These appointments were first notified in the New Zealand Gazette on 5 December 2002. At its first meeting, Mr B J Coutts was elected Chair of the Board pursuant to s.13(3) of the Act. These members were reappointed to the Board by the Minister for a further three years from 1 September 2006 and Mr Coutts was re-elected to the Chair at the meeting held on 13 October 2006. The statutory term of office for Board members is 3 years (Schedule 1(1)) but a Board member continues in office until a successor is appointed (Schedule 1(3)).

Meetings

The Board met 6 times in the 2008/09 year, on
21 and 22 August, 2008
23 and 24 October, 2008
28 November, 2008
11 February, 2009
16 and 17 April, 2009
26 June, 2009.

Licenses

The Board licensed 731 surveyors for the year ending 30 June 2009, four more than were licensed as at 30 June 2008.

Discipline

The Board accepted and heard a complaint from a private individual that had been received in the previous year. The surveyor was found to be not guilty of professional misconduct. During the reporting period the Board heard two complaints that were carried over from the previous reporting year. Following hearings held on 21 and 22 August 2008 the Board found two surveyors guilty of professional misconduct. The Board accepted two further complaints of professional misconduct against licensed cadastral surveyors and, following

hearings on 16 and 17 April 2009, found that one surveyor had been guilty of professional misconduct while the other surveyor was found not guilty.

The Board received two submissions from private individuals relating to the conduct of surveys, one of which was not accepted. The other complaint has not been fully considered by the Board as at 30 June 2009.

The Board now also issues an annual "Bulletin", which discusses and explains the results of disciplinary cases for the benefit of current licence holders, and contains any other items of information the Board considers appropriate or of interest.

Licensing Standards

Following consultation with the surveying profession the Board adopted and issued new standards and competencies for the licensing of cadastral surveyors pursuant to s.11(1)(d) on 3 September 2004. These Standards are being reviewed by the Board at present and will be released for public comment in the next reporting year.

The Board has continued to recognise the Admissions Interviews conducted by the New Zealand Institute of Surveyors Incorporated as evidence that applicants for new licences met the standards of competencies adopted by the Board. The Board monitors the conduct of these examinations.

As part of its responsibilities to monitor academic qualifications and practical requirements for the licensing of surveyors, the Board maintains contact with the National School of Surveying at the University of Otago, the only university in New Zealand that offers degrees in surveying.

Reciprocity

Full reciprocity between the various New Zealand Surveyors boards and the 8 Australian State and Territory Surveyors' boards has existed since 1901 although a reciprocity agreement with Australian boards had existed from 1892. The Board also collaborates with the Australian boards on the assessment of other overseas qualifications for equivalence to the New Zealand and Australian degrees and setting policies for the education, training and regulation of surveyors.

Contact with the Australian boards is maintained directly at board level through the Council of the Reciprocating Surveyors Boards of Australia and New Zealand, comprising the Chairs of each board. Meetings of the Council are generally held once per year. Mr Gawn represented the Cadastral Surveyors Licensing Board of New Zealand in place of the Chairman at the Council of Reciprocating Boards held in Canberra on 8 May 2009.

Legislation

The conduct of land subdivision and boundary surveys has been governed by published regulations since 1879. The current governance of surveys is by the Surveyor-General's Rules promulgated in June 2002 under section 49 of the Cadastral Survey Act 2002.

Finance

The Board is funded by licensing fees gathered annually from licensed cadastral surveyors. The level of those fees is set by the Board under s.11(1)(c) of the Act.

The fee for renewal of a license for the 2008/09 year was retained at \$136 plus GST (\$153.00) and has been maintained at the same level for the 2009/10 licensing year.

Administration

The Board has contracted the Institute of Professional Engineers New Zealand (IPENZ) to provide administrative services, office facilities and meeting rooms. IPENZ maintains full time office hours, dedicated telephone and facsimile point of contact, and hosts the Board's website.

Mr Rob Munro, solicitor, of Wellington, has been retained as the Board's legal advisor and Mr Ian Fargher has been the Board Secretary. Mr Fargher retires from the position of Secretary after almost seven years service to this Board, and a number of years as the Secretary of its predecessor, on 30 June 2009. Mr Fargher will be replaced as Secretary by Mr J R P Maseyk from 1 July 2009.

APPENDIX A: FUNCTIONS AND DUTIES

The functions and duties of the board, as set out in section 11 of the Cadastral Survey Act 2002 are:

- (a) To maintain a register of cadastral surveyors licensed under this Act.
- (b) To receive applications for licences under this Act as cadastral surveyors and to issue licences in proper cases.
- (c) To set fees for the issue and renewal of licences under this Act.
- (d) To issue and update standards that persons applying for licences, or the renewal of licences, under this Act must be met.
- (e) To investigate complaints about cadastral surveyors and take disciplinary action in appropriate cases under this Act.
- (f) To provide statistical information to the Minister about cadastral surveyors as requested by the Minister.
- (g) To perform such other functions or duties conferred on it by this Act or any other enactment.

APPENDIX B: AUDIT REPORT

To the Members of the Cadastral Surveyors Licensing Board of NZ

We have audited the financial report on pages 10 to 15. The financial report provides information about the past financial performance of the Cadastral Surveyors Licensing Board of NZ and its financial position as at 30 June 2009. 



Notes to the Financial Statements

for the Year Ended 30 June 2009

1. Statement of Accounting Policies

Reporting Entity

The financial statements presented here are for the reporting entity Cadastral Surveyors Licensing Board of New Zealand (CSLB) which commenced operations on 1 June 2002. Section 64 of the Cadastral Survey Act 2002 provided for the disestablishment of the Survey Board of New Zealand and for its assets and liabilities to vest in the CSLB.

Reporting Basis

The CSLB is required to prepare financial statements pursuant to Section 19 Cadastral Survey Act 2002.

Measurement Base

The measurement base adopted is historical cost.

Specific Accounting Policies

(i) Differential Reporting

The CSLB is a qualifying entity within the Institute of Chartered Accountants of New Zealand Differential Reporting Framework. The Board qualifies under the size criteria and because it is not publically accountable. The Board has taken advantage of all differential reporting exemptions available to it except for Financial Reporting Standard 10 Statement of Cash Flows.

(ii) Goods and Services Tax

The Statement of Financial Position and Performance have been prepared on a GST exclusive basis except for accounts receivable and payable which are GST inclusive.

(iii) Taxation

The entity is exempt from income tax on the basis that it falls under Section CW38 of the Income tax Act 2007.

(iv) Changes in Accounting Policies

There have been no changes in the accounting policies. All policies have been applied on basis consistent with those used in previous years

2. Nature and Activities of the Board

The Board was established by and operates under the Cadastral Survey Act 2002. This Act requires cadastral surveys to be done by, or under the direction of, a licensed cadastral surveyor, who must meet standards of competence to be licensed and to set standards for cadastral surveys and cadastral survey data. The board are responsible for the licensing of Cadastral Surveyors under this act and for the issuing of Annual License Certificates.

3. Annual Cadastral Surveyors License Fees

Annual Cadastral Surveyors License Certificates expire on 30 June each year. Applications for renewal each year may be lodged any time after 1 April for the following twelve months period commencing 1 July.

A number of applications for renewal are received and paid for in advance during the period between 1 April and 30 June each year. These License fees received in advance are shown separately on the Statement of Financial Position and are taken up as income in the financial year to which they relate.

4. Contingent Liabilities

The CSLB had no contingent liabilities as a balance date. (2008 Nil).

5. Commitments

The CSLB had no commitments as a balance date. (2008 Nil).

6. Related Party Transactions

During the year the CSLB has had no related party transactions. No related party debts have been written off or forgiven during the year.

7. Board Members Fees

During the course of business operations the Board Members received fees of \$31,645 (2008 \$22,295) for attending Board Meetings as follows:
